## Activity Consent form - Year 5 camp- QCCC Mapleton

Dear Parent/Carer

From Wednesday 28 July to Friday 30 July 2021, Year 5 students will be given the opportunity to attend a three-day camp run by the Queensland Conference and Camping Centre Mapleton (QCCC) on the Sunshine Coast as part of our school camping program.

The aims of the camp are as follows:

- Students will learn new outdoor recreational skills
- To promote physical fitness and active lifestyle
- Involve students in cooperation challenges and activities
- Develop social and cooperative skills and team building and decision-making skills
- To have an enjoyable and social experience in an outdoor setting
- To strengthen established relationships and develop new ones
- To be involved in activities related to the Australian Curriculum – Map reading, History (European Settlement)
- To develop independence skills by giving students the opportunity to look after themselves, their belongings and each other.

### Activity details:

Students will be involved in activities such as Archery, Canoeing, Orienteering, High Rope activities such as Giant Swing or Flying Fox, Bush Skills and team building activities. Camp staff, with the assistance of teachers will run all activities. All instructors have formal qualifications and experience and safety equipment will be worn at all times where appropriate.

Parents will be invited to an information session later in Term 2, once we have confirmation from the camp. A permission booklet will then be sent home where you can inform us of dietary requirements, medication and health issues. You will also be given a 'What to Bring' list at this time.
